

# *Sports Circle Indy Terms of Use*

Effective Date: July 13, 2020

Thank you for using our Site. The domain “sportscircleindy.org” (our “Site”) is operated by Sports Circle Indy (“SCI”), referred to herein as “we, “us”, or “our.”

Please read these terms and conditions of use carefully before using our Site. By using the Site, you signify your agreement to these Terms of Use (“Terms”). Unless a dispute would be governed by an applicable arbitration clause, you submit to the personal and exclusive jurisdiction of the courts located within the County of Marion, Indiana. If any part of these Terms are unlawful, void, or unenforceable, that part will be deemed severable and will not affect the validity and enforceability of any remaining provisions.

Our failure at any time to require performance of any provision of these Terms or to exercise any right provided for herein will not be deemed a waiver of such provision or such right. All waivers must be in writing. Unless the written waiver contains an express statement to the contrary, no waiver by SCI of any breach of any provision of these Terms or of any right provided for herein will be construed as a waiver of any continuing or succeeding breach of such provision, a waiver of the provision itself, or a waiver of any right under these Terms.
